Requirements and Selection

Requirements

As a double degree student will get an LSM Degree, they must fulfill the academic admission requirements as stated by LSM.

In order to register at LSM for the **Master's in Management**, they must hold a first cycle university degree (Bachelor's Degree), obtained after three years of study (180 ECTS), in Management or Economics (or any related field), issued by an LSM DD or CEMS partner school. If they have a Bachelor's degree issued by another school, some academic prerequisites are required, namely 18ECTS in Economics, 27ECTS in Management, 24ECTS in Quantitative Methods, 24ECTS in Human and Social Sciences (incl. Law) and 15ECTS in languages (this last point can be compensated by the DD selection interview done in English).

In order to register at LSM for the **Master's in Business Engineering**, they must hold a first cycle university degree (Bachelor's Degree), obtained after three years of study (180 ECTS), in Management or Economics (or any related field), issued by an LSM DD or CEMS partner school, including 36 credits in Quantitative Methods, Science and Technology. If they have a Bachelor's degree issued by another school, some academic prerequisites are required, namely 39ECTS in Economics and Management, 36ECTS in Quantitative Methods, Science and Technology, 18ECTS in Human and Social Sciences (incl. Law) and 15ECTS in languages (this last point can be compensated by the assessment during the interview of the student's level of English).

In addition to the above admission requirements, there are <u>specific selection criteria</u> for the double degree:

- A good grade point average for the Bachelor's degree (preferably "above average")
- English proficiency: C1 level (CEFR) assessed during the selection interview
- A strong motivation, with a coherent study plan

Selection process

Once you have good candidate.s who is/are interested in the double degree with LSM, you can contact Catherine Maréchal to set a date for the 20-minute joint selection interview (note the UCL application deadlines below depending on the EU or non-EU nationality of the candidate).

The selection will be done twice: before the start of the Master's program (March-May) and during the first semester of the Master's program (October). A joint selection team will decide the admission in the DD program.

Enrolment at UCL-LSM for selected candidates

Enrolment Process in order to be

Once the candidate has been jointly selected by the schools, they will need to officially enrol at UCL; this is a mandatory administrative procedure for all incoming UCL students.

officialy registered at UCL-LSM

Once this administrative procedure is completed, the official « autorisation d'inscription » will be delivered to the student. It is with this document only that the

selected candidate can apply for a **visa** (for non-European citizens).

The step-by-step enrolment process will be detailed in an email. Estelle Tonon will send

that email at the end of February-beginning of March.

Application **Deadlines**

April 30 is the deadline to fill in the online admission form (and upload documents) for

non-EU citizens

August 31 is the deadline for EU citizens

Fees Administrative fees of 66 euros will be requested for the academic year.

Master's Program

Exact title of LSM Degree

- « Master en sciences de gestion, à finalité spécialisée » for the Master's in Management
- « Master en ingénieur de gestion, à finalité spécialisée » for the Master's in Business Engineering

Workload for an incoming DD student

A normal minimum workload is 60 ECTS per academic year.

Thanks to the bilateral agreement between the two partner universities, LSM will recognise at least 60 ECTS done at the home university. The other more or less 60 ECTS in order to get the LSM degree are usually composed as follows for an incoming double degree student:

- . A major (30 ECTS)
- . A course in Corporate Social Responsibility and two seminars (10 ECTS)
- . A Master's thesis (20 ECTS)

Available Majors

A major worth 30 ECTS is composed of 6 courses of 5 ECTS each. The program is organized fully in English, but the LSM also proposes other majors with courses taught in French. If the student has a B2 level in French, he/she can select those majors as well. Program will be checked to avoid any redundancy.

- . Corporate Social Responsibility (4 ECTS)¹
- . Seminar in Relational and Managerial Competences (3 ECTS)
- . Seminar in Current Managerial Issues (3 ECTS)

Master's Thesis

A Master's thesis is an individual paper worth 18 ECTS (at LSM) where the student works on a specific topic linking theory and critical thinking, jointly supervised by two professors (one from each institution).

The student submits a written Master's thesis and presents it during an oral defense (please note that, at LSM, the oral defense is part of the Master's thesis assessment and is therefore mandatory).

Teaching languages

English and French. A full track in English is possible. Some majors have courses taught in French. If an incoming double degree student wishes to take a course taught in French, he/she must prove a B2 level in French (upper-intermediate).

Accommodation & Visa

Accommodation

There is a limited amount of accommodation managed by the university; however, incoming double degree students will have the exceptional possibility to automatically get university housing for their academic year.

Concretely, the student will have to, for the ease of colleagues managing accommodation, fill in an online form in March.

Housing conditions and costs

For an entire academic year: lease from September 15 to July 14 (10 months) for a shared flat or 12 months for a studio/flat.

Rent ranges from € 275 to € 330 per month. A deposit is usually required. The accommodation is available as from September 15th! NOT BEFORE.

If the DD incoming student arrives before that date, they will have to find temporary housing i.e. kot Erasmus, Youth Hostel, ...

Visa to Belgium for NON-EU

From non-European Union countries, the ASP student visa is compulsory. Chinese exchange students are exempt from the ASP procedure.

The UCL registrar's office will mail the UCL "autorisation d'inscription" directly to the home residence of the student (indicated on the UCL registration form). This document has to be sent to the Embassy/Consulate in order to apply for the visa.
